

ORDINANCE No. 184254

* Accept a grant in the amount of \$70,000 and appropriate \$53,000 for FY 2010-11 for the Oregon Association Chiefs of Police for the Three Flags Campaign/Safety Belt enforcement program grant for personnel overtime (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Bureau applied to the Oregon Association Chiefs of Police for the Three Flags Campaign/Safety Belt enforcement program grant for officer overtime on September 15, 2010. The objective of the Campaign is to increase compliance with Oregon's occupant restraint laws towards the State's goal of reducing traffic crash fatality and injury rates.
2. The Oregon Association Chiefs of Police (OACP) has notified the City of Portland that it will award a grant for the Three Flags Campaign/Safety Belt enforcement program to the Police Bureau in the amount of \$70,000.
3. The OACP will reimburse the City a maximum of \$70,000 for expenses incurred by the bureau for Traffic Division personnel overtime hours worked on the Three Flags Campaign/Safety Belt program. The reimbursement rate is \$40.00 per hour.
4. This grant requires a cash match of two hours straight-time enforcement for every one hour of overtime worked enforcing occupant restraint laws. Local match in the amount of \$127,820 shall be provided by funds from City of Portland matching funds in the form of personnel expenses in the FY 2010-11 and FY 2011-2012 budgets of the Police Bureau. The City will also incur payroll expenses for the hourly overtime rates above the grant's \$40.00 per hour limit and all benefit expenses related to grant overtime in the form of personnel expenses in the FY 2010-11 and FY 2011-2012 budgets of the Police Bureau.
5. The grant period is October 1, 2010, through September 30, 2011.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Association Chiefs of Police for the Three Flags Campaign/Safety Belt enforcement program grant in the amount of \$70,000.
- b. The FY 2010-2011 budget is hereby amended as follows:

- c. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

- d. The Chief of the Police Bureau of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications by the Oregon Association Chiefs of Police for the Three Flags Campaign/Safety Belt enforcement program grant, #OP-11-45-08, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
