

ORDINANCE No. 184318

*Amend contract with Team HR LLC for \$6,837 to provide additional team development services for the Office of Human Relations (Ordinance; amend Contract No. 30001666)

The City of Portland ordains:

Section 1. The Council finds

1. On September 13th, 2010 a contract was entered into between the City of Portland (City) and Team HR to provide the Office of Human Relations team development services.
2. The original Contract amount was \$3,150 with and expiration date of June 30, 2011.
3. Additional services are required because of the amount of work required to meet team development goals.
4. Contract No. 30001666 shall be amended to increase the compensation by \$6,837 with the same expiration date of June 30, 2011.
5. Total compensation for the contract will not exceed \$10,000.
6. Sufficient funding resides in the OHR Professional Services Fund for FY 2010-11.


NOW THEREFORE, The Council directs:

- a. The Commissioner in Charge to authorize amending Contract No. 30001666 with Team HR LLC for services in accordance with Amendment No. 1 attached hereto as Exhibit A.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver checks payable to Team HR chargeable to the office of Human Relations Professional Services Fund when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists in order to maintain the existing schedule of team development work with the Office of Human Relations; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
