

**ORDINANCE No. 184332**

Amend contract with Rick Hlavka dba Green Solutions in the amount of \$25,475 to provide additional Food Scrap Curbside Collection Pilot Waste Composition Analysis services (Ordinance; amend Contract No. 30001299)

The City of Portland ordains:

Section 1. The Council finds:

1. On April 15, 2010 a contract was entered into between the City of Portland (City) and Rick Hlavka DBA Green Solutions to provide Food Scrap Curbside Collection Pilot Waste Composition Analysis services.
2. The original Contract amount was \$22,500 with an expiration date of December 31, 2010.
3. Amendment No. 1, dated July 15, 2010, provided for additional samples in July and an additional round of sampling and sorting in December and increased the original compensation by \$5,625. The new not-to-exceed contract amount was increased to \$28,125.
4. Additional Food Scrap Curbside Collection Pilot Waste Composition Analysis services are required. The Bureau of Planning and Sustainability recommends that Contract No. 30001299 with Rick Hlavka DBA Green Solutions be amended to increase the compensation by \$25,475 and extend the expiration date to January 31, 2012.
5. The additional compensation under this Ordinance, along with previously added compensation, comes to \$31,100, which is 138% of the original compensation amount of \$22,500. The new not-to-exceed amount of the Contract is \$53,600.
6. Sufficient funding resides in the Solid Waste Management Fund PNSD000004 for FY 2010-2011


NOW THEREFORE, the Council Directs:

- a. The Chief Procurement Officer is authorized to amend Contract No. 30001299 with Rick Hlavka DBA Green Solutions for services in accordance with Amendment No. 2 attached hereto as Exhibit A.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver checks payable to Rick Hlavka DBA Green Solutions chargeable to the Bureau of Planning and Sustainability when demand is presented and approved by the proper authorities.


