

ORDINANCE No. 184358

Authorize funding agreement with members of the Washington Park Alliance for the benefit of Washington Park. (Ordinance)

The City of Portland ordains:


Section 1. The Council finds:

1. Portland Parks & Recreation (PPR), Hoyt Arboretum Friends Foundation, the Japanese Garden Society of Oregon, the World Forestry Center, the Oregon Zoo, and the Portland Children's Museum all operate within Washington Park and comprise a destination attraction for visitors and residents of the region.
2. These entities have voluntarily formed the Washington Park Alliance, a coalition to facilitate collaboration on various issues that are of interest to all the entities.
3. To fund the projects and initiatives of the Washington Park Alliance, it is necessary that all member organizations contribute an annual fee of \$2000.
4. The attached funding agreement is a five year agreement, retroactive to July 1, 2010, that requires each party to contribute the annual fee, subject to available funding.
5. The parties expect to enter into a more comprehensive agreement in the future that addresses, among other things, collaborative decision making, joint funding of projects, and resource sharing.

NOW, THEREFORE, The Council Directs:

- a. The Director of Portland Parks and Recreation is authorized to execute a funding agreement with Hoyt Arboretum Friends Foundation, the Japanese Garden Society of Oregon, the World Forestry Center, the Oregon Zoo, and the Portland Children's Museum in a form substantially similar to the attached and as approved as to form by the City Attorney.
- b. The Commissioner-in-Charge of Portland Parks & Recreation is authorized to execute future agreements with the membership of the Washington Park Alliance so long as such agreements are approved as to form by the City Attorney and do not obligate the City to make financial contributions greater than available funding.


