

**ORDINANCE No. 184426**

\*Pay claim of Mary Maes involving Bureau of Environmental Services. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Mary Maes has filed a property damage claim against the City for damages suffered in sewer back-up involving BES on October 22, 2010.
2. The claim has been investigated by Risk Management Services.
3. Risk Management Services recommends the claim be compromised for the total sum of \$5,875.00, subject to the claimant providing the City with a release in a form to be approved by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$5,875.00 made payable to Mary Maes.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.





