**ORDINANCE No. 184476**

\*Pay claim of Advantis Credit Union involving Bureau of Development Services and Bureau of Transportation. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Advantis Credit Union has filed a property damage claim against the City for damages suffered from a permitting error on Sept. 2, 2009, regarding right-of-way construction involving the Bureau of Development Services and the Bureau of Transportation.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
3. Risk Management Services recommends the claim be compromised for the total sum of \$10,982, subject to the claimant providing the City with a release in a form to be approved by the City Attorney. Risk Management has previously advanced \$5,000, so the additional amount payable under this Ordinance is \$5,982.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$5,982 made payable to Advantis Credit Union.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

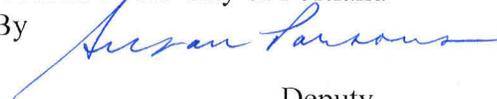
