

# ORDINANCE No. 184477

Authorize a contract and provide for payment for the construction of the Westside & Eastside Sewer Rehabilitation Project No. E09121 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Approximately 12,000 feet of combined sewer main located in the southeast, northwest and southwest areas of Portland will be repaired using cured-in-place pipe (CIPP). The sewer main in this project is in difficult areas to access with many of the sewers located under homes.
2. Environmental Services has prepared plans and specifications for rehabilitating the sewers manholes and service laterals.
3. Environmental Services requires the furnishing of materials and labor for this project.
4. The estimated cost is \$4,000,000. The level of confidence in this estimate is high. Funds are available in the Bureau of Environmental Services Sewer System Operating Fund, FY 2010-2011, Project No. E09121.


NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
