

ORDINANCE NO. 184495

* Amend subrecipient contract with 211*info* to add \$42,625 for website transition to improve services for low-income homeowners and renters (Ordinance; amend Contract No. 32000389)

The City of Portland ordains:

SECTION 1. The Council finds that:

1. The City of Portland passed Ordinance No 184015 authorizing Subrecipient Contract No. 32000389 with 211*info* to provide housing and social services information and referral, including support of the Housing Connections website.
2. Funding in the amount of \$42,625 in CDBG funds will be added to this contract through amendment for one-year not to exceed amount of \$266,425 through the allocation of existing appropriations in the City's existing FY 2010-11 Budget (\$213,425 in CDBG Fund, \$53,000 in General Fund).
3. The additional funds will be used to work with City, Fair Housing Council of Oregon, and HousingPoint software vendor, Bowman Systems, Inc. to transition from existing Housing Connections website to HousingPoint software, which assists low-income homeowners and renters to find housing and housing assistance.

NOW, THEREFORE, the Council directs:

- a. The Bureau Director and the City Auditor are hereby authorized to amend Subrecipient Contract No. 32000389 with 211*info* in accordance with the amendment attached as Exhibit A.
- b. The Mayor and City Auditor are hereby authorized to make payment chargeable to the FY 2010-11 Budget when demand is presented and approved by the proper authority.

SECTION 2. The Council declares that an emergency exists because delay may result in incomplete execution of necessary work; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
