*Create a new Nonrepresented classification of Parks and Recreation Asset Manager and establish a compensation rate for this classification (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. In accordance with the policies established by the City Council and based on a classification and compensation review, the Bureau of Human Resources is creating a new classification effective January 1, 2011.


