## ORDINANCE No. 184543

\* Authorize an Intergovernmental Agreement with Oregon State Police Crime Lab for the use of U.S. Department of Justice, Office of Justice Programs, National Institute of Justice FY10 Solving Cold Cases with DNA grant funds (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The U.S. Department of Justice (USDOJ), Office of Justice Programs (OJP), National Institute of Justice (NIJ) FY10 Solving Cold Cases with DNA grant program awarded grant funding to the City.
- 2. The purpose of the Agreement is to address payment for services provided by and supplies purchased by the Oregon State Police Crime Lab for work performed on cold cases submitted by the PPB Detectives Cold Case unit as part of the USDOJ grant.
- 3. The City will, with USDOJ OJP NIJ grant funds, reimburse the Oregon State Police Crime Lab for the cost of all approved personnel expenses and material costs not to exceed \$99,283.72.
- 4. This agreement shall begin January 1, 2011, and extend through the length of the grant or until grant funds are exhausted, whichever comes first.

NOW, THEREFORE, the Council directs:

a. The Mayor and City Auditor are hereby authorized to enter into an agreement substantially in accordance with the agreement attached as Exhibit A.

Section 2. The Council declares an emergency exists because delay in proceeding with the attached agreement may result in the delay of solving Cold Case Homicides. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
