ORDINANCE No. 184572

*Amend Intergovernmental Agreement with the Portland Development Commission for economic development activities. (Ordinance; amend Contract No.30001830)

The City of Portland ordains:

Section 1. The Council Finds:

- 1. The Portland Development Commission (PDC) and the City entered into an Intergovermental Agreement (IGA), dated November 17, 2010, that established terms and conditions by which one party engages and compensates the other party for performing specific services.
- 2. During the City's FY 2010-11 Winter Budget Monitoring Process (Winter BMP), City Council appropriated an additional \$350,000 for PDC's economic development activities as follows: \$200,000 for cluster industry and targeted recruitment; \$150,000 for small business working capital.
- 3. The Ordinance authorizing the IGA requires Council to approve amendments related total compensation.

NOW THEREFORE, the Council directs:

- a. The Chief Administrative Officer (CAO) is authorized to amend, on behalf of the City, Subrecipient Contract No. 30001830 with PDC, in a form substantially similar to the amendment attached as Exhibit A.
- b. The CAO is authorized to execute amendments to this IGA on behalf of the City, except for those amendments related to the total compensation in the IGA.
- c. The City Attorney shall approve as to form all further amendments prior to their execution.

Section 2. The Council declares that an emergency exists because a delay may interrupt PDC's ability to carry out the activities as outlined in Exhibit A; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
