

ORDINANCE No. 184593

Amend contract with Parametrix for additional work and compensation for the SE 83rd Avenue Wastewater Pump Station Project No. E08376 (Ordinance; amend Contract No. 37227)

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Environmental Services (BES) has need of continuing professional engineering services provided by Parametrix for the SE 83rd Wastewater Pump Station project.
2. Parametrix is continuing to provide professional engineering services under Contract No. 37227, effective March 23, 2007, with an expiration date of March 22, 2012.
3. The estimated cost for the proposed contract amendment is \$55,271. Funds are available in the Sewer System Operating Fund, FY 2010-2011 Budget, Bureau of Environmental Services, Project E08376.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract amendment with Parametrix for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
