The City of Portland Ordains:

Section 1. The Council finds:

- 1. The City Council has received a memorandum from the Financial Planning Division of OMF (FPD) summarizing the recommendations and consequent budget adjustments to be made during the FY 2010-11 Spring Supplemental Budget Process.
- 2. The memorandum identified programs, projects, or activities that required appropriation adjustment or transfer of appropriation within bureau budgets.
- 3. Exhibit 1, attached, includes all incremental changes to the City appropriation schedule as a result of the Spring Supplemental Budget Process.
- 4. Exhibit 2, attached, shows, for informational purposes, a reconciliation of changes to all funds.
- 5. Exhibit 3, attached, shows, for informational purposes, all requests materially affecting the General Fund.

NOW THEREFORE, the Council directs:

- a. The FY 2010-11 Appropriation Schedule is hereby amended by adjusting appropriations for certain expenditures in various funds as indicated by the increases and decreases presented in Exhibit 1.
- b. The actions amending the FY 2010-11 budget contained in this ordinance are binding City policy.

Section 2. The Council declares that an emergency exists in order that FY 2010-11 Spring budget adjustments are implemented without delay; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
