ORDINANCE No. 184620

Revise transportation fees, rates and charges for FY 2011-2012 and fix an effective date (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- The Approved Budget for the Bureau of Transportation for Fiscal Year 2011/12 requires 1. adjustments to fee rates and charges for the 12-month period beginning July 1, 2011.
- 2. Transportation has consolidated all fee rates and charges into schedules as set forth in Attachment A (TRN-3.450 Transportation Fee Schedule) and Exhibit A and Exhibit B of this Ordinance. The consolidated schedules do not preclude the establishment and/or continuation of fees, rates and charges by resolution, ordinance, Code provision or administrative rule, not otherwise specified in the Ordinance.
- 3. In accordance with policies adopted by City Council, the proposed adjustments to transportation fee rates and charges are based upon cost of service principles, ensuring equity by charging ratepayers according to the service they use and maximizing flexibility in the use of City revenue sources to meet the cost for services of broader public benefit.
- 4. Transportation's Budget Advisory Committee and the City's Office of Management and Finance has reviewed and approved Transportation's updated service fees and fee development charge methodology; and City Council has reviewed these fee and rate charges as part of the FY 2011/12 budget process.

NOW, THEREFORE, the Council directs:

- a. The adoption of fee rates and charges in accordance with the Fiscal Year 2011/12 budget. beginning July 1, 2011, as set forth in the attached Exhibit A and Exhibit B.
- TRN-3.450 Transportation Fee Schedule, and Exhibit A and Exhibit B of this Ordinance b. are binding city policy.
