

ORDINANCE No. 184621

Authorize an Intergovernmental Agreement with Local Government Personnel
Institute for legal advice and consultation (Ordinance)

The City of Portland Ordains:

Section 1. The Council finds:

1. The City Attorney's Office requires expert services and consultation for matters relating to contract negotiations.
2. Local Government Personnel Institute has appropriate staff and expertise to advise the City Attorney's Office.
3. It is estimated that the cost of the services required is \$25,000.

NOW, THEREFORE, the council directs:

a. The City Attorney is authorized to enter into an Intergovernmental Agreement for legal services with the Local Improvement Personnel Institute, in the amount of \$25,000. The City Attorney is authorized to amend the IGA before or after execution, as may be required to change the dates for performance or cost of services.


b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the bureau requesting specialized consultation and advice work.
