

ORDINANCE No. 184637

*Amend Legal Services Agreement with Patton Boggs LLP for outside counsel.
(Ordinance; amend Contract No. 30001864)

The City of Portland ordains:

Section 1. The Council finds:

1. The City of Portland required the services of outside legal counsel to work on behalf of the City to monitor appropriate federal legislative committees, agencies and interest groups for the 2011 session.
2. The law firm of Patton Boggs LLP entered into Legal Services Agreement No. 30001864 to provide these services as they relate to the 2011 federal legislative sessions.
3. It is necessary to increase the amount of the agreement to complete payment for such services and to extend the length of this agreement to allow for payment.


NOW, THEREFORE, the Council directs:

- a. The City Attorney is authorized to amend Legal Service Agreement No. 30001864, in an additional amount of \$33,000, bringing the final total of this contract to \$133,000.
- b. The City Attorney is authorized to extend the terms of Agreement No. 3001864 until September 20, 2011 for work performed through August 31, 2011.
- c. If applicable, the provisions of City Code Chapter 5.68 are waived.
- d. The Mayor and Auditor are authorized to draw and deliver warrants in payment of legal services provided under this Legal Services Agreement.

Section 2. The Council declares that an emergency exists in order to continue payment for legal services being provided for Counsel's work with Government Relations regarding federal legislation; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
