## ORDINANCE No. 184696

\* Authorize an Intergovernmental Agreement with the Oregon State Police Criminal Investigations Division for the use of Oregon Department of Justice Oregon High Intensity Drug Trafficking Area Program grant funds for work on drug related cases (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. The Oregon Department of Justice was awarded \$1,247,400 by the Office of National Drug Control Policy's High Intensity Drug Trafficking Area (HIDTA) Program to support initiatives designed to implement the strategy proposed by the Executive Board of the Oregon HIDTA Program and approved by the Office of National Drug Control Policy (ONDCP);
- 2. The Police Bureau Drugs and Vice Division HIDTA Interdiction Team (HIT) provides efforts in disrupting and dismantling drug trafficking organizations in Multnomah, Washington and Clackamas Counties by employing a multi-agency approach to significantly impact drug availability in the area;
- 3. The purpose of the Agreement is to address payment for services provided by the Oregon State Police Criminal Investigations Division for work performed as a subcontractor on drug-related cases;
- 4. The City will, with ODOJ HIDTA grant funds, reimburse the Oregon State Police Criminal Investigations Division for the cost of all approved program expenses not to exceed \$75,400; and
- 5. This agreement shall begin January 1, 2011, and extend through the length of the 2011 and 2012 HIDTA grant periods or until grant funds are exhausted, whichever comes first.

## NOW, THEREFORE, the Council directs:

a. The Mayor and City Auditor are hereby authorized to enter into an agreement substantially in accordance with the agreement attached as Exhibit A.

Section 2. The Council declares an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
