

ORDINANCE No. 184742

Authorize a contract and provide for payment for the construction of the SE 12TH & Gideon Sewer Reconstruction Project No. E08661. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Combined sewer reconstruction is required in order to mitigate basement flooding.
2. The Bureau of Environmental Services requires the furnishing of materials and labor for this project.
3. The estimated cost is \$1,300,000. The level of confidence in this estimate is optimal. Funds are available in the Sewer System Operating Fund, FY 2011-2012 Budget, Bureau of Environmental Services Cost Object, E08661.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.




