Authorize a contract and provide for payment for the construction of the SE 12TH & Gideon Sewer Reconstruction Project No. E08661. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. Combined sewer reconstruction is required in order to mitigate basement flooding.
- 2. The Bureau of Environmental Services requires the furnishing of materials and labor for this project.
- 3. The estimated cost is \$1,300,000. The level of confidence in this estimate is optimal. Funds are available in the Sewer System Operating Fund, FY 2011-2012 Budget, Bureau of Environmental Services Cost Object, E08661.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
