*Authorize a contract and provide for payment for Emergency Coordination Center project. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The design for the Emergency Coordination Center is complete and construction documents were prepared and have gone out to public bid. The Emergency Coordination Center includes construction of both a new building as well as the relocation of a section of SE Bush Street.
- 2. The cost to construct the new street and building for the Emergency Coordination Center is estimated to be \$11,000,000. The construction estimate is within the project budget.
- 3. The Emergency Coordination Center is designed to meet the LEED Gold certification as well as all other conditions of the City's "Green Building Policy" and the State of Oregon's 1.5% for Solar program.

NOW THEREFORE, the Council directs:

- a. The Mayor and Auditor are hereby authorized to enter into a contract with the lowest responsive and responsible bidder for the Emergency Coordination Center project.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the 2011-2012 budget when demand is presented and approved by the proper authorities.

SECTION 2. The Council declares that an emergency exists to avoid a delay in proceeding with the Contract; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
