

ORDINANCE No. 184913

*Authorize agreement between Portland Parks & Recreation and Sellwood-Moreland Improvement League, Inc. to define roles and responsibilities at Oaks Pioneer Church (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The City of Portland through its Portland Parks & Recreation (Parks) is the owner of Oaks Pioneer Church located at 455 SE Spokane Street, Portland, Oregon.
2. The Sellwood-Moreland Improvement League, Inc. (SMILE) is an incorporated non-profit Oregon corporation with the primary purpose of improving the Sellwood-Moreland neighborhood.
3. SMILE has provided special event rental and maintenance services to the City of Portland since 1969 in connection with the historic Oaks Pioneer Church and the adjacent gardens.
4. The most recent contract was approved by the City of Portland on December 8, 1993 via Ordinance No. 167169. Parks and SMILE wish to update roles and responsibilities under a new agreement attached to this Ordinance.

NOW, THEREFORE, the Council directs:

- a. The Director of Parks and Recreation is hereby authorized to execute an Agreement, substantially similar to the attached Exhibit A and as approved as to form by the City Attorney, with Sellwood-Moreland Improvement League, Inc.

Section 2. The Council declares that an emergency exists in order to avoid further delay in ensuring public use of the property needed for park and recreational purposes; therefore, this Ordinance shall be in force and effect from and after its passage by Council.



