

ORDINANCE No. 184941

* Amend an Intergovernmental Agreement with Multnomah County to fund mental health services at the Gateway Center for Domestic Violence Services (Ordinance; amend Contract No. 30000956)

The City of Portland ordains:

Section 1. The Council finds:

1. In ordinance No. 184592 Council authorized the City to enter into an intergovernmental agreement with Multnomah County to share equally the cost of providing mental health services to clients at the Gateway Center for Domestic Violence Services.
2. An intergovernmental agreement, No. 30000956, was entered into with Multnomah County.
3. The annual cost to provide such services is \$33,500.00. Multnomah County also contributes \$33,500.00 to fund such services.
4. In the FY 2011/12 budget Council approved ongoing funding of \$33,500.00 to pay for mental health services.
5. An extension of the intergovernmental agreement is necessary to continue mental health services at the Gateway Center for Domestic Violence Services.

NOW, THEREFORE, the Council directs:

- a. The Commissioner of Public Affairs is hereby authorized to enter into an extension of the agreement with Multnomah County, No. 30000956, for five consecutive one-year periods.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the General Fund, in payments as delineated in the attached extension agreement, which shall not exceed \$33,500.00.

Section 2. The Council declares an emergency exists because a delay in proceeding with this agreement will delay payment to Multnomah County for ongoing mental health services at the Gateway Center for Domestic Violence Services; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


