

ORDINANCE No. 184949

* Accept a grant in the amount of \$50,000 and appropriate \$40,000 for FY 2011-12 from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance FY 2011 Gang Resistance Education and Training Grant Program - Evaluation Sites (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Bureau applied to the United States Department of Justice (USDOJ), Office of Justice Programs (OJP), Bureau of Justice Assistance (BJA) FY 2011 Gang Resistance Education and Training (G.R.E.A.T.) Grant Program - Evaluation Sites (Local) for a grant in the amount of \$50,000 for funding, which will aid in the delivery of the Elementary and Middle School curricula as well as the G.R.E.A.T. Families and Summer Components on July 27, 2011; and
2. The United States Department of Justice has notified the City of Portland that it will award a grant for the G.R.E.A.T. Local program to the Police Bureau in the amount of \$50,000; and
3. The USDOJ will reimburse the City a maximum of \$50,000 to fund program expenses, including overtime for sworn personnel instruction, travel and program supplies for 12 months; and
4. The grant requires a 10 percent local match, which will consist of Salary and Fringe Benefit expenses for 2.0 FTE program personnel currently assigned to the G.R.E.A.T. Local program; and
5. The grant period is October 1, 2011, through September 30, 2012.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance for the FY 2011 Gang Resistance Education and Training Grant Program - Evaluation Sites in the amount of \$50,000.
- b. The FY 2011-12 budget is hereby amended as follows:

GRANTS FUND

Fund - 217

Business Area – PL00

Bureau Program Expenses - \$40,000

- c. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.
- d. The Chief of the Police Bureau of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications to the U.S. Department of Justice for the FY 2011 Gang Resistance Education and Training Grant Program - Evaluation Sites, #2010-JV-FX-0010, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.




