1) Legislation Title: Amend Public Improvement Code to reflect accurate Bureau Director and City Engineer responsibilities; update, clarify and reorganize sections; delete outdated sections; add new regulations for preservation of the 5th and 6th Avenue Transit Mall; and codify existing policies regarding hazardous materials in the public right-of-way (Ordinance; amend Title 17)

2) Purpose of the Proposed Legislation:

This is an update to Title 17, Public Improvements, of the City Code.

The proposed amendments make Title17 consistent with Council's intent when it created the position of Director of Transportation by making the Director responsible for administrative and policy decisions which were previously assigned to the City Engineer. The City Engineer remains responsible for engineering decisions as mandated by Oregon Revised Statute and City Charter.

Outdated and no longer relevant Code sections are deleted.

Language regarding permits has been updated to reflect current language used in utility franchise agreements and new language has been added to address excavation and restoration of the reconstructed Transit Mall.

Existing policy language regarding hazardous materials in the right-of-way has been updated and codified per the City Attorney's recommendation.

The amendments also reorganize some chapters of Title 17 by moving related regulations into related chapters to make it easier for the public, permittees and staff to find information.

This is primarily an administrative clean up of existing code. There are limited changes to existing regulations in concurrence with existing policies and practices. The changes primarily affect utility providers.

The proposed amendments were sent to all Neighborhood Coalitions, all Neighborhood Association Chairs, the Development Review Advisory Committee and all franchised and City owned utilities requesting review and comment. All parties were given at least sixty days for review and comment.

Public meetings

January, 13, 2011 all utility providers were invited to a public meeting. No utility provider attended.

July 27, 2011 a meeting was held with the Neighborhood Coalition Land Use Committee Chairs. The Portland Homebuilders representative also attended. At the request of the Neighborhood Coalition Land Use Chairs the time for allowed for public comment was extended 23 days.

August 16, 2011 briefed Development Review Advisory Committee at their regular meeting.

PBOT received four written comments, two from utility providers and two from neighborhood association representatives.

The utility comments were regarding restrictions on excavations of the Transit Mall and the boundaries of the underground wiring district below the Portland Aerial Tram. These two concerns have been addressed in manner satisfactory to the Portland Bureau of Transportation and the utility providers.

Two neighborhoods provided comments. Both asked that the City consider undertaking a broader policy review of the Local Improvement District regulations and the Sidewalk regulations. The two neighborhood associations responding recognized that those requests were outside the scope of this project but wished to be on record that they believed a comprehensive review of these two areas was needed.

c) How did public involvement shape the outcome of this Council item?

There was limited public influence as this is primarily a technical clean up of existing code with no proposed policy changes.
