## ORDINANCE No. 184971

Approve the designation of six trees as City of Portland Heritage Trees (Ordinance).

The City of Portland ordains:

Section 1. The Council finds:

- 1. Section 20.40.150 of the City Code provides for the listing, designation and maintenance of Heritage Trees within the city which, because of their age, size, type, historical association or horticultural value, are of special importance to the city.
- 2. The Heritage Tree Committee has inspected and evaluated six significant Portland area trees recently nominated for inclusion in the Heritage Tree program. The Committee has presented its findings to Portland's Urban Forestry Commission, a volunteer body with varying backgrounds on tree care issues. The Urban Forestry Commission recommends that Council designate these trees as Heritage Trees.

- a. Under the provisions of PCC 20.40.150, the following six trees are designated as Heritage Trees and are included in Portland's Heritage Tree Program:
- 1. Metasequoia glyptostroboides, dawn redwoods (12) in Upper Macleay Park
- 2. Sequoiadendron giganteum, privately owned giant sequoia at 5810 SE Taylor St.
- 3. Acer pseudoplatanus, publicly owned sycamore maple at 2607 NE Wasco St.
- 4. *Cedrus atlantica*, privately owned blue atlas cedar at 7000 SW 63<sup>rd</sup> Ave.
- 5. Diospyrus virginiana, publicly owned American persimmon at 6440 NE 36<sup>th</sup> Ave.

6. Larix kaempferi, privately owned Japanese larch at 4626 NE 37<sup>th</sup> Ave.

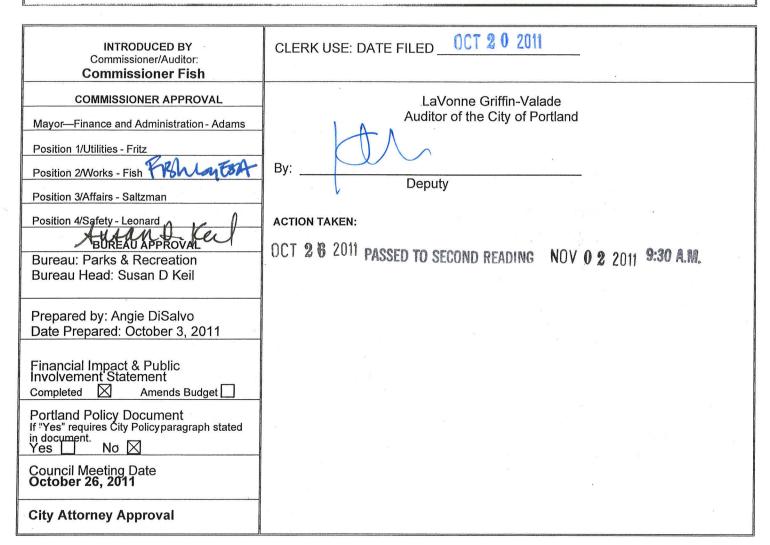
