ORDINANCE No. 184986

*Authorize contract with Online Business Systems for computer systems design, maintenance and programming services for the Bureau of Fire and Police Disability and Retirement (Ordinance).

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Bureau of Fire and Police Disability and Retirement (FPDR) currently has a contract with a technology vendor, which will expire on December 31, 2012.
- 2. The FPDR is in need of a technology vendor to migrate the FPDR database to a current technology platform before the existing support contract expires and to provide continuing computer systems design, maintenance and programming services.
- 3. A competitive bid process through the City's Request for Proposal procedure was conducted and the Selection Committee selected Online Business Systems as the highest ranked respondent.
- 4. On September 27, 2011, the Board of Trustees of the FPDR, by its Resolution No. 467, approved Online Business Systems as its technology vendor to provide computer systems design, maintenance and programming services and authorized the FPDR Director to enter into an Agreement with Online Business Systems.
- 5. A budget of \$240,000 has been established in the FPDR fund for FY 2011-2012 for the migration project.
- 6. An appropriate form of the agreement is attached hereto as Exhibit "A".

NOW, THEREFORE, the Council directs:

a. The FPDR Director is hereby authorized to execute a contract with Online Business Systems in a form substantially in accordance with the Agreement attached hereto as Exhibit "A".

Section 2. The Council declares that an emergency exists in order that the computer systems design, maintenance and programming services may begin as stated in Exhibit "A" so that the migration project can be completed prior to the expiration of the current system support contract. Therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
