ORDINANCE No. 185033

*Authorize Third Addendum to Lease Agreement between the City and Robert C. Hunt, Lessee, to renew the Lease for vehicle parking space for an additional five years (Ordinance; amend Contract No. 50613)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City entered into a Lease Agreement with Robert C. Hunt, owner of East Bank Saloon, for vehicle parking space located under the east end of the Morrison Bridge effective January 1, 1996 and terminating December 31, 2001.
- 2. Pursuant to Section 5 of the Lease, Lessee has three five-year options to renew the Lease commencing upon the expiration of the original term.
- 3. The Lessee has exercised two of the three options to renew the Lease with the current extension due to expire on December 31, 2011. The Lessee, is requesting to exercise his third and final option to renew the Lease for an additional five year period until December 31, 2016.
- 4. Pursuant to Section 5.b., Option to Renew, the Lease provides for an adjustment in rent at the commencement of the renewal term increased by the Consumer Price Index. Therefore the rent for the renewal term ending December 31, 2016 shall be Two Hundred Twenty dollars (\$220.00) per month.
- 5. All other terms and conditions of the Lease shall remain the same.

NOW, THEREFORE, the Council directs:

- a. That the Mayor and the Auditor are hereby authorized to execute the Third Addendum on behalf of the City, as approved by the City Attorney, substantially in accordance with the Addendum attached to the original of this Ordinance as Exhibit A, and by this reference made a part hereof.
- b. The Auditor is hereby authorized to return the executed document to Robert C. Hunt for signature at 727 SE Grand Avenue, Portland, 97214.
