ORDINANCE NO. 185087

* Correct clerical errors regarding total amount of Transition Projects subrecipient contract for a Winter Warming Center (Ordinance; amend Ordinance No. 184982)

The City of Portland ordains:

Section 1. The Council finds that:

1. Ordinance No. 184982, was passed by City Council on November 9, 2011.
2. Ordinance No. 184982 and its associated Exhibit A incorrectly identified the total Original Amount Contracted and New Full Amount Contracted for the Transition Projects omnibus contract such that the collective not-to-exceed amount for the identified contracts was also incorrect.
3. The described errors were clerical errors limited to the Ordinance document, and those clerical errors do not affect actual amounts budgeted, obligated, or contracted for the activities identified within Ordinance No. 184982.

NOW THEREFORE, the Council directs that:

- a. Ordinance No. 184982 is amended to correctly read: "Funding in the amount of \$367,000 in City general funds will be added to these subrecipient contracts not to exceed the amount of ~~\$2,388,971~~ \$3,847,567 through the allocation of existing appropriations for this purpose in PHB's FY 2011-12 Ending Homelessness Initiative budget.
- b. Exhibits A and B of Ordinance No. 184982 are amended as attached.


