Amend contract with Skylab Architecture LLC for additional work and compensation for the Columbia Boulevard Wastewater Treatment Plant Support Facility Project No. E09023 (Ordinance; amend Contract No. 30001585)

The City of Portland ordains:

- Section 1. The Council finds:
 - 1. The Bureau of Environmental Services (BES) has a need of continued professional architectural and engineering services provided by Skylab Architecture LLC for the completion of design, permitting, and construction support services for the Columbia Boulevard Wastewater Treatment Plant (CBWTP) Support Facility, Project No. E09023.
 - 2. Skylab Architecture is providing professional architecture and engineering services under Contract No. 30001585, effective on August 2, 2010 with an expiration date on October 2, 2013.
 - 3. This Contract Amendment will authorize additional work for phased road work documentation, project renderings, waterproofing consultation, enhanced building commissioning, cost estimating, and support for a conditional use master plan application including civil engineering and traffic consulting in the total amount of \$82,689 for a new not-to-exceed contract amount of \$1,026,612.
 - 4. The established cost of this contract amendment is \$82,689. Funds are available in the Sewer System Operating Fund, FY 2012 Budget, Bureau of Environmental Services Project Number E09023.
 - 5. M/W/ESB participation after the authorization of this contract amendment will be \$548,181, 53.4% of the total amended contract amount of \$1,026,612.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute an amendment to Contract No. 30001585 with Skylab Architecture LLC, in a form substantially in accordance with the amendment attached as Exhibit "A", for the purpose described in Section 1, in the amount of \$82,689.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.




