

ORDINANCE NO. 185135

*Authorize application to the State Historic Preservation Office for a Historic Preservation Fund Grant in the amount of \$14,500 to support the City's historic resources program. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The State Historic Preservation Office (SHPO) invited the City of Portland as a Certified Local Government to apply for a Historic Preservation Fund Grant.
2. The Historic Preservation section of the Bureau of Planning and Sustainability is requesting the Historic Resources Fund Grant. The grant will fund projects including survey work, preservation planning, and supplementing program funding for the City's historic resources program. Funds requested for this grant total \$14,500 for the period April 16, 2012 to August 31, 2013.
3. Local match in the amount of \$14,500 will be provided by funds from the historic resources program, Green Building team (PNSD000002) for FY 2011-12 and FY 2012-13. The match will be in the form of salary, benefits, and materials and services in the FY 2011-12 and FY 2012-13 budgets of the Bureau of Planning and Sustainability.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to make application to the State Historic Preservation Office for a grant in the amount of \$ 14,500.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because the grant application must be submitted no later than February 24. Therefore this ordinance shall be in full force and effect from and after its passage by the Council.



