## ORDINANCE No. 185149

\*Authorize a contract and provide for payment for The Portland Building Penthouse Stucco Replacement and 14<sup>th</sup> Floor Roof Replacement project. (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. The design for The Portland Building Penthouse Stucco Replacement and 14<sup>th</sup> Floor Roof Replacement project is complete with construction documents 95% complete and almost ready to go out to public bid.
- 2. The cost to replace the penthouse stucco and 14<sup>th</sup> floor roof for The Portland Building is estimated to be \$800,000. The construction estimate is within the project budget. The project estimate confidence level rating is high.

## NOW THEREFORE, the Council directs:

- a. The Mayor and Auditor are hereby authorized to enter into a contract with the lowest responsive and responsible bidder for The Portland Building Phase I Penthouse Stucco Replacement and 14<sup>th</sup> Floor Roof Replacement project.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the 2011-2013 budget of Facilities Services when demand is presented and approved by the proper authorities.

SECTION 2. The Council declares that an emergency exists to avoid a delay in proceeding with the Contract; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
