\*Amend contract with Ball Janik LLP for outside legal counsel (Ordinance; amend Contract No. 30000350)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. The City required the services of outside legal counsel for advice regarding insurance coverage.
- 2. The law firm of Ball Janik LLP, agreed to provide these services by Legal Services Agreement No. C30000350 dated March 9, 2009.
- 3. Due to the nature of the matter and the likelihood that it will go to litigation, it is necessary to increase the amount of this contract and extend the terms of the agreement by two years.

## NOW, THEREFORE, the Council directs:

- The City Attorney is authorized to extend Legal Service Agreement No. a. C30000350, dated March 1, 2009, to provide for representation by outside counsel in an additional amount of \$100,000, for a total not to exceed \$125,000.
- b. The terms of the agreement are extended to February 28, 2014.
- If applicable, the provisions of City Code Chapter 5.68 are waived. C.
- d. The Mayor and Auditor are authorized to draw and deliver warrants in payment of legal services provided under this Legal Services Agreement.

Section 1. The Council declares that an emergency exists in order to continue to pay for legal services in a timely manner regarding the City's insurance coverage issues: therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
