

ORDINANCE No. 185199

*Extend Intergovernmental Agreement with Oregon Department of Transportation for work on a portion of the Columbia Slough Trail (Ordinance; amend Contract No. 53046)

The City of Portland ordains:

Section 1. The Council finds:

1. The Columbia Slough Trail is part of the 40-Mile Loop, a state recreational trail, which currently ends at the southeast corner of the Portland International Raceway (PIR) just west of N. Denver Road.
2. Oregon Department of Transportation (ODOT) established a Community Enhancement Fund of \$1,000,000 to mitigate adverse impacts of the I-5 Delta Park freeway.
3. Portland Parks & Recreation (PP&R) will receive \$460,000 of the ODOT funds for trail work, to be matched with \$150,000 from PP&R Trail System Development Charges, to design and build trail from N. Denver to N. Vancouver Road approx. 7185 feet.
4. Ordinance 181602, passed by Council Feb. 6, 2008, accepted the \$460,000 Community Enhancement grant.
5. It has now been determined by State and Agency that the Agreement referenced above shall be amended to extend the project completion and termination date, revise project scope, update Agency Project Manager and update standard language.


NOW, THEREFORE, The Council Directs:

a. The Commissioner in charge and the Auditor are authorized to accept the agreement amendment in a form substantially in accordance with the Amendment No. 1, attached as Exhibit A.


