## ORDINANCE No. 185221

Amend contract with Otak, Inc. for professional project management and engineering services for the design of the East Lents Floodplain Restoration Project - Phase 2 Project No. E08464 (Ordinance; amend Contract No. 38100)

## The City of Portland ordains:

## Section 1. The Council finds:

- 1. During development of the design for Phase 2, the need to add additional scope of work and budget to the Otak, Inc. contract for the design of public improvements was identified.
- 2. This Amendment No. 3 will authorize additional work in the amount of \$247,200 for a new not-to-exceed amended contract amount of \$2,364,267. This amendment contains the revised scope-of-work, budget, deliverables and delivery schedule necessary to complete the design of Phase 2 of the East Lents Floodplain Restoration Project. The cost estimate level of confidence is "Optimal".
- 3. Funds are available in the Sewer System Operating Fund, FY Budget, Bureau of Environmental Services, Cost Center, WBS Element, Internal Order.
- 4. M/W/ESB participation after the authorization of this contract amendment will be about 8% of the total amended contract amount of \$2,264,267.

## NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract amendment with Otak, Inc., substantially in conformance with the contract amendment and exhibits attached hereto, for the purpose described in Section 1, in the amount of \$247,200.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
