The City of Portland ordains:

Section 1. The Council finds:

- 1. The design for the roof replacement at the Police North Precinct, the Walnut Park Retail Center, and the Police St. John's Training Facility is complete with construction documents 95% complete.
- 2. The cost to replace the roof on these buildings is estimated to be \$2,240,000. The construction estimate is within the project budget. The project estimate confidence level rating is high.

NOW THEREFORE, the Council directs:

- a. The Chief Procurement Officer and Auditor are hereby authorized to enter into a contract with the lowest responsive and responsible bidder for Police North Precinct, the Walnut Park Retail Center, and the Police St. John's Training Facility Roof Replacement project.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the 2011-2012 through 2012-2013 budget of Facilities Services when demand is presented and approved by the proper authorities.

SECTION 2. The Council declares that an emergency exists to avoid a delay in proceeding with the Contract; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
