

ORDINANCE No. 185245

Accept donation of two ACU-1000 Communications Units from the State of Oregon (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Oregon Department of Transportation Statewide Interoperability Coordinator has offered to donate two ACU-1000 Communications Units to the City of Portland, Bureau of Emergency Management (PBEM). These units are valued at \$7,150 each, for a total of \$14,300.
2. The primary use of the ACU-1000 is to simultaneously connect different radio networks and connect radio networks to telephone or satellite communication systems.
3. The primary location for the units will be in the PBEM communications trailer.
4. Per PCC 5.36.090 (A) the Mayor is authorized to accept any and all personal property or the use thereof.

NOW, THEREFORE, the Council directs:

- a. The Mayor or his designee is authorized to accept the donation of two ACU-1000 Communications Units from the State.
- b. PBEM is directed to add the two ACU-1000 Communications Units to the City's inventory.


