Accept contract with Global Diving & Salvage, Inc. for the construction of the Bull Run Dam 1 Outlet Works Improvements, Phase 2, as complete, release retainage, and authorize final payment (Report; Contract No. 30000667)

On July 7, 2009, the City entered into Contract No. 30000667 with Global Diving & Salvage, Inc., for the replacement of the stems of seven sluice gates and repair of concrete in the spillway of Bull Run Dam 1 for a Contract amount of \$786,506. The final cost of the project is \$1,262,766. The actual cost is 61% over the original contract amount for the project. All work on the contract was completed satisfactorily on August 30, 2010. The Final Payment to be made in the amount of \$3,000 is to release the remaining retainage.
