*Authorize application to the U.S. Environmental Protection Agency for a \$200,000 grant for Brownfield Cleanup at 10420 SE 106th & SE Foster Road (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City of Portland is committed to encouraging the remediation of brownfield sites within the City.
- 2. The EPA's Brownfield Cleanup Grant Program provides funds to carry out cleanup activities at a specific brownfield site owned by the City of Portland.
- 3. BES is preparing a grant application to submit to EPA requesting funds in the amount of \$200,000 for Brownfield Cleanup at 10420 SE 106th & SE Foster Road, a City-owned property acquired through the Johnson Creek Willing Seller Program.
- 4. The grant from EPA requires a 20% non-federal match. Local match in the amount of \$40,000 will be provided in the form of salary and benefits in the FY 2011/12 and FY 2012/13 proposed budgets of the Bureau of Environmental Services. Matching funds are available in the Sewer System Operating Fund, Bureau of Environmental Services, ESPP000017 / PUPPECBF000000BE.

NOW THEREFORE, the council directs:

- a. The Mayor is hereby authorized to make an application to the EPA for a grant in the amount of \$200,000.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.
