

ORDINANCE No. 185280 As Amended

*Authorize a \$3,500 grant agreement with Chess for Success for a Neighborhood Small Grant for the Chess for Success at Lincoln Park Elementary School project (Ordinance)

The City of Portland ordains:

SECTION 1. The Council finds:

1. The Neighborhood Small Grants Program provides neighborhood and community organizations an opportunity to expand their community-building capacity, attract new and diverse members and sustain those already involved.
2. This program has been adopted as part of the FY 2011-12 Office of Neighborhood Involvement (ONI) budget and is funded with a total of \$223,039 through City General Fund dollars. \$41,472 of these funds is allocated to East Portland Neighborhood Office for projects in outer East Portland.
3. East Portland Neighborhood Office, which is a city-administered District Coalition, is distributing their allocated funds to three grantees including \$3,500 to Chess for Success for the Chess for Success at Lincoln Park Elementary School project.

NOW, THEREFORE, the Council directs:

- a) The Director of the ONI and the City Auditor are authorized to execute a grant agreement on behalf of the City in a form substantially in accordance with Exhibit C in the amount of \$3,500.
- b) Amendments to the grant agreement may be agreed to and executed by the Director of ONI or his/her designee provided those amendments do not increase the fiscal risk to the City.
- c) The Director of the ONI and the City Auditor are hereby authorized to pay for said grant agreement from the Office of Neighborhood Involvement general funds.


