

ORDINANCE No.

185281 As Amended

*Authorize a \$30,336 grant agreement with East Portland Neighbors, Inc. to administer Neighborhood Small Grants for fourteen community and neighborhood building projects (Ordinance)

The City of Portland ordains:

SECTION 1. The Council finds:

1. The Neighborhood Small Grants Program provides neighborhood and community organizations an opportunity to expand their community-building capacity, attract new and diverse members and sustain those already involved.
2. This program has been adopted as part of the FY 2011-12 Office of Neighborhood Involvement (ONI) budget and is funded with a total of \$223,039 through City General Fund dollars. \$41,472 of these funds is allocated to East Portland Neighborhood Office for projects in outer East Portland.
3. East Portland Neighborhood Office, which is a city-administered District Coalition, is distributing their allocated funds to three grantees including \$30,336 to East Portland Neighbors (EPN) to administer funds for sixteen different projects.

NOW, THEREFORE, the Council directs:

- a) The Director of the ONI and the City Auditor are authorized to execute a grant agreement on behalf of the City in a form substantially in accordance with Exhibit A in the amount of \$30,336.
- b) Amendments to the grant agreement may be agreed to and executed by the Director of ONI or his/her designee provided those amendments do not increase the fiscal risk to the City.
- c) The Director of the ONI and the City Auditor are hereby authorized to pay for said grant agreement from the Office of Neighborhood Involvement general funds.

SECTION 2. The Council declares that an emergency exists because there a number of community groups that are waiting for funding and inflation will diminish; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
