

ORDINANCE No. 185300

Accept donation of 1918 American LaFrance triple combination pumper and leather fire helmet from the Jeff Morris Fire & Life Safety Foundation. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Jeff Morris Fire & Life Safety Foundation is in possession of a 1918 American LaFrance triple combination pumper and leather fire helmet and matching parade belt.
2. Jeff Morris would like to donate said equipment to Portland Fire & Rescue (PF&R).
3. The approximate value of the donation is \$32,000.00.
4. The Fire Chief recommends that the Council accept the donation from Jeff Morris Fire & Life Safety Foundation.

NOW, THEREFORE, the Council directs:

- a. The City Council accepts the donation of the 1918 American LaFrance triple combination pumper, leather fire helmet, and matching parade belt for Portland Fire & Rescue, and thanks Jeff Morris Fire & Life Safety Foundation for its donation.




