The City of Portland Ordains:

Section 1. The Council finds:

- 1. The City Council has received a memorandum from the Financial Planning Division (FPD) of the Office of Management and Finance (OMF) summarizing the budget adjustments to be made during the FY 2011-12 Spring Supplemental Budget Process.
- 2. The memorandum identifies programs, projects, or activities that require appropriation adjustment or transfer of appropriation within bureau budgets.
- 3. Exhibit 1, attached, includes all incremental changes to the City appropriation schedule as a result of the Spring Supplemental Budget Process.
- 4. Exhibit 2, attached, shows, for informational purposes, a reconciliation of changes to all funds.
- 5. Exhibit 3, attached, shows, for informational purposes, all requests materially affecting the General Fund.

NOW THEREFORE, the Council directs:

- a. The FY 2011-12 Appropriation Schedule is hereby amended by adjusting appropriations for certain expenditures in various funds as indicated by the increases and decreases presented in Exhibit 1.
- b. The actions amending the FY 2011-12 budget contained in this ordinance are binding City policy.

Section 2. The Council declares that an emergency exists in order that FY 2011-12 Spring budget adjustments are implemented without delay; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
