

ORDINANCE No. **185395** **As Amended**

Authorize the Chief of Police or designee to execute Access and Indemnification Agreements with property owners for installation of surveillance equipment on their property (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Improving the livability of the residential and commercial environment in areas of Portland that have been degraded by regular and persistent open air drug related crimes is a critical priority.
2. Council adopted Resolution No. 36858 in support of the addition of a Deputy District Attorney and re-establishment of the Walking Beat Program for arrest and prosecution of drug crimes in Illegal Drug Impact Areas on April 20, 2011.
3. Installation and monitoring of video surveillance equipment will assist in active arrest, prosecution and court supervision of offenders in drug related crimes, reducing the impact of crime in areas determined to have significant open air drug-related crimes and improving the livability of the neighborhood
4. This Authorization allows the Chief of Police, or designee to execute Access and Indemnification Agreements with property owners for the sole purpose of installing video surveillance equipment.

NOW, THEREFORE, the Council directs:

- a. The Mayor and Auditor hereby authorize the Chief of Police, or designee, to enter into access and indemnification agreements with property owners in a form substantially in accordance with the agreement attached as Exhibit A.


