

ORDINANCE No. 185456

*Amend an Intergovernmental Agreement with Clackamas County for the distribution of equipment, supplies and services procured as a result of Urban Areas Security Initiative Grant awards. (Ordinance; amend Contract No. 30002299)

The City of Portland ordains:

Section 1. The Council finds that:

1. The City of Portland has been awarded an FY 2011 Urban Areas Security Initiative (UASI) Grant #11-170. The FY 2011 UASI Grant award of \$4,925,160 (Ordinance #185227) is for addressing the unique equipment, training, planning, exercise and operational needs of large urban areas.
2. The City of Portland is the official administrator for the UASI regional grants.
3. Clackamas County is a stakeholder in the UASI region.
4. Currently the IGA will expire December 31, 2012. This amendment will extend the IGA to May 31, 2014.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the City Auditor are authorized to execute an amendment to Contract No. 30002299 between the City of Portland and Clackamas County as outlined in a form substantially in accordance with the attached Amendment No. 1.
- b. The Mayor and the Auditor hereby are authorized to draw and deliver checks chargeable to the UASI FY 2011 Grant Budget, when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists so as to maximize the grant award period of performance. Therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
