

ORDINANCE No. 185494

* Amend a contract with LifeWorks Northwest in an amount not to exceed \$240,000 and extend the term through June 30, 2013 to work with the Police Bureau Prostitution Coordination Team (Ordinance; amend Contract No. 30002562)

The City of Portland ordains:

Section 1. The Council finds:

1. The Portland Police Bureau's Prostitution Coordination Team (PCT) is a program designed to reduce crime and improve the lives of people caught in the cycle of addiction and criminality.
2. LifeWorks Northwest is a mental health, addictions, and social services agency that operates a variety of outpatient, outreach, day treatment, and residential chemical dependency and mental health services for citizens of Multnomah, Washington and Clackamas Counties, regardless of ability to pay.
3. LifeWorks Northwest offers services at an easily accessible location for East Portland residents and East Precinct officers and has ample space for program services. Staff located at this site includes a masters-level clinician, a Case Manager, a Substance Abuse Counselor and a psychiatric provider.
4. LifeWorks Northwest currently operates New Options for Women (NOW) to provide services specifically designed to meet the needs of prostituted women. Program staff are generally women to best serve the women within the NOW program.
5. The City wishes to amend Contract No. 30002562 by extending the term of the agreement through June 30, 2013 and increase compensation in an amount not to exceed \$240,000 as outlined by the attached Exhibit A.
6. The City will fund the project with a \$140,000 grant from the U.S. Department of Justice, Office of Justice Programs, Bureau of Justice Assistance FY12 Justice Assistance Grant Program.
7. The City will support the remaining contract amount with a General Fund one-time Special Appropriation of \$100,000 allocated in the FY2012-13 Budget.
8. Due to the immediate need for a continuation of the FY 2011-12 contract to prevent a lapse in this program, it serves City and public interest for this ordinance to be in full force and effect immediately upon passage by Council.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to execute a contract amendment with LifeWorks Northwest substantially in accordance with the attached Exhibit A on behalf of the City for the purposes identified in Section 1, provided the procurement meets all the requirements of PCC 5.68 and all City procurement rules, policies and regulations.

Section 2. The Council declares that an emergency exists because a delay would deprive the City and LifeWorks Northwest of the benefits of the agreement. This amendment is time-sensitive to the fiscal year and as such cannot afford the longer processing time of a non-emergency ordinance. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.


