The City of Portland ordains:

Section 1. The Council finds:

- 1. The Centers for Disease Control and Prevention (CDC) is soliciting projects for grant funding under the Community Transformation Grants Program.
- 2. The program is funding projects that reduce obesity in targeted populations through policy, environment, infrastructure, and programmatic interventions.
- 3. The Bureau of Transportation intends to apply for a grant aimed at increasing physical activity among residents through interventions aimed at increasing walking and bicycling rates in select Populations.
- 4. No match is required by this grant.

NOW THEREFORE, The Council directs:

- a. The Mayor is hereby authorized to make application to the Federal Centers for Disease Control for a grant in the amount of \$750,000.
- b. The Mayor is authorized to provide such information and assurances as are required for the grant period.
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because the grant application is due on July 31, 2012. Therefore this ordinance shall be in full force and effect from and after its passage by the Council
