Changes to the City's budget were amended in the FY 2010-11 budget adjustments, and the City removed the fund prior to the FY 2011-12 Adopted Budget. At this time, the balance in the Campaign Finance Fund was reimbursed to the General Fund Overhead funds; additionally, the City did not budget for the Campaign Finance Fund in the FY 2011-12 Adopted Budget. Once the final accruals were made for FY 2010-11, the fund was closed according to city procedure.
