The next date where five Communication spots are open is Wednesday, September 12th.

Note the following is the Auditor's Office policy to schedule a Communication:

- **Individuals must request their own Communications in writing by either email (my email below), fax (number below), U.S. mail or hand delivered (address below).**

- Request have to include the date you wish to speak, speaker's name, address, phone number and a few sentences regarding the issue you will be speaking to.
- Deadline is Thursday at 5:00 p.m. the week before to sign up for the following Wednesday meeting. We do limit speakers to the first 5 who sign up and we do not hold spots.
- Requests are limited to one scheduled communication per calendar month.
- Requesters may schedule no more than two months in advance.
- The requestor will have three minutes to address the Council but may also submit written material, please provide 7 copies.

Request are placed on the Wednesday morning Agenda under "Communications" and are the first item on the Official Agenda which starts at 9:30 a.m. In the event the meeting is canceled, you will be notified of the next available open date.

Council takes place at City Hall, 1221 SW 4th Ave., 2nd Floor, Council Chambers.

Note - Communications allow the Council to hear of issues that interest our citizens, but do not allow an opportunity for dialogue.
