Amend contract with Michael Willis Architects to increase compensation and scope of work for Interstate Maintenance Facility Rehabilitation – Design Services (Ordinance; amend Contract No. 30001654)

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Water Bureau entered into Contract No. 30001654 with Michael Willis Architects to provide design services for the Interstate Maintenance Facility Rehabilitation Project.
- 2. This amendment provides additional design services, construction administration, and extends the term of the contract.
- 3. The original contract provided for \$350,428, or 18.6%, of the contract dollars being awarded to State of Oregon certified Minority, Women, or Emerging Small Businesses. Upon execution of this amendment \$762,225.66 or 23.9% of the contract dollars will be awarded to Minority, Women, or Emerging Small Businesses.
- 4. The original not to exceed value of this contract was \$1,885,034. Amendments 1 through 7 have added \$469,458. This amendment will add \$869,538.50 and increase the contract total to \$3,224,030.50, an overall increase of 71%. Funding for the project is available in the FY 2012-13 Budget and requested in FY 2013-14, FY 2014-15, and FY 2015-16 Budgets.

NOW, THEREFORE, the Council directs:

- a. That the Commissioner-in-Charge is authorized to execute on behalf of the City an amendment to Contract No. 30001654 with Michael Willis Architects in a form substantially in accordance with the amendment attached as Exhibit A.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the Water Fund when demand is presented and approved by the proper authorities.
