

**ORDINANCE No. 185653**

Amend contract with Dignity Village to extend contract terms to November 30, 2012 to give additional time to finalize details of the new contract (Ordinance, amend Contract No. 53015)

The City of Portland ordains:

**SECTION 1. The Council finds**

1. The City Council passed ordinance No. 180959 on May 16, 2007 authorizing a contract with Dignity Village, a nonprofit organization, to manage a transitional housing campground at Sunderland Yard.
2. Portland Housing Bureau (PHB) completed an evaluation of the campground, also called Dignity Village, in February 2010. The evaluation recommended many modifications to Contract C53015.
3. PHB requires additional time to meet with other City Bureaus, as well as Dignity Village stakeholders, therefore extending the contract terms to November 30, 2012 to finalize the details of a new contract with the Village.

NOW THEREFORE, The Council directs:


